The federal governments inability to adequately account for and reconcile Reconciling intragovernmental activity and balances between federal agencies has Intragovernmental been a long-standing problem and major impediment to us being able to render an opinion on the CFS. Resolving this difficult challenge will Activity and Balances require, among other things, strong leadership and oversight by Treasury and OMB. Treasury and OMB require federal agencies to reconcile selected 20 intragovernmental activity and balances with their trading partners and report the extent and results of the reconciliation efforts to Treasury.
